

Note 1:	In continuation to our earlier reporting, we would further like to reiterate that we have disclosed consolidated shareholding of those promoters entities which have multiple demat accounts. Accordingly, number of shareholders/entities have been reduced from 55 (in main shareholding) to 41 (in above table) under promoter and promoter group category.
Note 2:	Data received from M/s Link Intime (India) Pvt. Limited i.e. RTA, for the quarter ended September 30, 2014, has shown 86,70,800 equity shares of promoter and promoter group entities as "encumbered" and the promoter and promoter group entities have also confirmed the same. Hence, based on the disclosure received from the promoter and promoter group entities and also the information received from the RTA, we have disclosed 86,70,800 equity shares (8.67%) of promoter and promoter group entities as "encumbered" out of total holding of promoter and promoter group entities i.e. 1,77,31,808 equity shares (17.73%) held in GHCL Limited.
