

Note: Board of Directors of GHCL Limited in their meeting held on January 31, 2017 had given their approval for Buy Back of the Company's fully paid-up equity shares of Rs. 10/- each from the Open Market through Stock Exchange route, at a Maximum Buyback price of Rs. 315/- per Equity Share excluding transaction costs, for an aggregate amount of Rs. 80 Crores.
In line with the said approval, the Company had bought back 31,56,000 equity shares from February 15, 2017 till August 14, 2017 (i.e. scheduled closure date) and all the bought back shares were extinguished on August 16, 2017. Accordingly, Issued & Paid-up Capital of the Company stands reduced to 9,68,63,286 Equity Shares (10,00,19,286 minus 31,56,000) after buyback.
