Note: In continuation to our earlier disclosures in the form of note to Promoters' Shareholding under Clause 35 of the Listing Agreement for the quarter ended June 30, 2010, September 30, 2010 & December 31, 2010, March 31, 2011, which were filed on July 16, 2010, October 7, 2010, January 12, 2011 & April 15, 2011 respectively, we would like to inform that arbitration proceeding between Indiabulls Financial Services Limited (IFSL) and Promoters of the Company is still in progress. We would like to invite your attention that vide Arbitration order dated July 23, 2009, certain promoter entities of GHCL were restrained from selling, transferring, or creating third party interest in any manner in respect of eighty six lacs seventy thousand and eight hundred equity shares which is 8.67% of total equity shares of the Company. Copy of said award is already marked to the Stock Exchanges as well as NSDL/CDSL.

However, as per Section 12 of the Depositories Act, 1996 read with Regulation 58 of the SEBI (Depositories and Participants) Regulations, 1996, abovesaid equity shares (i.e. 8.67%) held by the promoters have not been marked as pledged. Moreover, as per our Register of Members dated June 30, 2011 based on data received from NSDL/CDSL through our RTA, M/s Link Intime India Private Limited, the said shares have not been marked as pledged or otherwise encumbered. Further, since the arbitration matter is still going on and promoter companies have not reported pledge on these shares and also Register of Member shows aforesaid shares as unencumbered or free, accordingly we have reported these shares in Promoters shareholding as unencumbered as per legal opinion of an expert obtained in this regard and also consistently reporting in this manner.
