

In line with the said approval, the Company had bought back 5,73,438 Equity Shares and extinguished 5,46,550 Equity Shares during the quarter ended March 31, 2017. Accordingly, Issued & Paid-up Capital of the Company stands reduced from 10,00,19,286 Equity Shares to 9,94,72,736 Equity Shares (i.e. 10,00,19,286 minus 5,46,550) as on March 31, 2017.
