# GHCL announces Q2/H1 FY25 Results PAT increased by 8% in Q2 FY25 YoY (Standalone basis)

**New Delhi, 29**<sup>th</sup> **October, 2024:** GHCL, India's leading Chemical Company, today announced its financial results for Q2/H1 FY25.

Commenting on the financial performance, Mr. R S Jalan, Managing Director, GHCL Limited said, "We are glad to report a resilient Q2 performance, with a clear focus on operating excellence. Realizations stayed tempered during the quarter despite some increase in net imports of Soda Ash.

Going forward, globally, the pricing may remain range-bound as industry challenges have not yet fully resolved and potential risks persist due to the ongoing geopolitical situations.

Domestic prospects in Soda Ash look positive due to steps taken by GoI to encourage production of solar glass, including the 10% import duty levied on imports. Our performance going forward will be supported by planned expansion initiatives around Vacuum Salt and Bromine, which will start contributing from next year onwards. Overall, we remain focused on driving a highly efficient business that prioritizes profitable growth in a constrained environment and are committed to maximizing shareholder value through strategic decision-making and effective execution."

#### **Financial Performance (Standalone)**

#### **Q2 FY25 VS Q2 FY24**

- **Net Revenue** declined by 1% to Rs. 810 crores as compared to Rs. 817 crores in the corresponding quarter of the previous year
- EBIDTA increased by 2% to Rs. 228 crores as compared to Rs. 224 crores in the Q2 FY24
- Net Profit grew by 8% to Rs. 155 crores as compared to Rs. 143 crores in the Q2 FY24

#### **H1 FY25 VS H1 FY24**

- **Net Revenue** declined by 10% to Rs. 1,659 crores as compared to Rs. 1,846 crores in the H1 FY24
- EBIDTA declined by 13% to Rs. 463 crores as compared to Rs. 534 crores in the H1 FY24
- **Net Profit** before exceptional items declined by 13% to Rs. 305 crores as compared to Rs. 350 crores in the H1 FY24
