- 1. Order by Commissioner CGST & Excise, Bhavnagar, confirming demand of excise duty on manufacture & removal of STPP for the period from July 2011 to October 2012.
- 2. Order by Asst. Commissioner CGST, Junagadh, confirming demand on grounds of non-payment of GST on District Mineral Foundation (DMF) and National Mineral Exploration Trust (NMET) w.r.t. charges paid on limestone/ lignite for the period from July 2017 to March 2019.

The Company has strong ground to contest the matter and shall file appeal with appellate authorities in due course.
